2) Welcome Remarks from the Chair (T. Park)

Thomas provided opening remarks and thanked the staff, volunteers, and members who made the 2022 Festival a success. Thomas noted that the board will be undergoing a leadership and succession planning review and will update the members as this progresses.

3) Interim Co-Heads Report (E. Chivi/A. Murphy)

Elie and Andrew presented an overview of activities in 2022. Highlights included the following:

Programming:

- Return to in-person screenings after two years.
- 128 films from 28 countries.
- 66% of content made by women/trans/non-binary filmmakers.
- 55% of content made by BIPOC-identified filmmakers.
- 26% Canadian content.
- 12 films in selection received RE:Focus post production funds.

Industry and Professional Development

- 8 feature films participated in the finance forum.
- More than 20 companies represented.
- Expanded Industry Day.
- More than \$30,000 in prizes given to filmmakers.
- ASL interpreters present for Industry Day.
- Panels were livestreamed and recorded.

Accessibility and Community Engagement

- 100% of feature and shorts content was captioned or fully subtitled.
- ASL interpretation for intros and Q&As when the filmmaker was in attendance.
- All but 5 features and 2 shorts were available digitally.
- Over 50 community partners.

Sponsorship

- Year 1 of 3 with RBC.
- RBC investment in the RE:Focus Fund and library.
- Onboarded 7 new sponsors.

Attendance and Engagement

Nearly 10,000 audience members in person and online.

Marketing

- 20,000% increase in the number of accounts reached.
- 879% increase in the number of accounts engaged.
- Significant increase in Instagram followers.
- 81 pieces of coverage.
